Thank you once again to everyone, both past and new exhibitors, for the amazing response we have received so far. In 2015 'Is Everybody Here...' has grown again to be one of the largest community inclusion expos of its kind to be held in the Moreton Bay Region.

Please note if you would like to be involved in the Expo but not stay until the end of the Festival you can apply for an Expo Site which runs from 10am until 4.30pm.

Public Liability can also be an issued for some organisations therefore we have attached an indemnity form (page 4) which can be signed & returned with the application if no insurance is held.

The Expo: Is for Community Organisations, Not-for-Profits, Government Sectors and relevant Commercial Enterprises who are all welcomed to exhibit their service and be involved. The expo commences at 10am and finishes at 4.30pm. **Please note:** Due to safety factors No vehicle are to be moved within the event grounds during those times.

The Festival: Consists of Rides, food, live all day entertainment, prizes/give-aways that will all be part of the day and concludes with a fire work show at 7pm.

'Is Everybody Here...' provides an opportunity for all businesses, government, corporate, community or not-for-profits to join together for a day aimed at informing, entertaining, fundraising and supporting opportunities for our entire community including people with disabilities, mental health, Multicultural, Indigenous, all of our Youth, our Elderly and every single other citizen.

Sites costs are as little as \$75.00 for an unpowered 3 x 3m & \$110.00 for a powered 3 x 3. Larger sites are available at 6 x 3m for \$110.00 unpowered or \$150.00 for powered. For all food Stall outlets the fee is \$250.00 per Stall.

(If payment is received by the 31st August 2015 you will be entitled to a 10% discount for all site fees)

- Sites to be secured without the use of ground peg (unless by prior arrangement with event coordinator.)

- If Exhibitor/Stall Holder cancels after booking a site, there will be a \$20.00 Administration Fee.

All confirmation acceptances NEED TO BE accompanied with:

1. A copy of the exhibitor/stallholders Public Liability Insurance to the value of \$20million (**NB: Also see conditions of indemnity on the form (page 4)**)
2. A cheque/money order or direct debit receipt to the value of your site fee. Please ensure there is a reference on the direct debit such as your business name (This is very important to ensure we reconcile your payment)**
